The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.

The School is required to apply on online for further extension of affiliation along with t 2. tequisite fee and other documents by 80th June of the preceding year in which the Provision Affiliation expires as per Rule 15.11 of Affillation Bye Laws.

The school wilkfollow the syllabus on the basis of curriculum prescribed by NCERT/CBSE at 3. text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabil and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Seconda School Examination and changes made therein from time to time.

The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time

The school and its records shall be open for inspection by an officer/official of the Board or a authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government time to time.

Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.

21 Pay and allowances to staff should be revised time to time to bring it at par with that to State Government/Govt. of India Turther, Salary and Service conditions of staff should be provided in accordance with Rule no 3.3 (v) and Rule no 10.2 as appended below
